The Parks and Recreation Plan is intended to help guide improvements to recreation facilities in the community for the next five years. The process to develop the Plan included an online public survey in October 2021-November 2021. A draft plan has been completed, and the Village is required to have a 30 day public comment review period to give residents an opportunity to review and comment on the Plan prior to adoption.

A public hearing to adopt the Plan has been scheduled for 7:00 PM on January 19, 2022 at the Page Memorial Building during the next regular meeting of the Village Council. The draft Plan is available and may be examined by the general public at the Page Memorial Building during regular business hours, and at the public hearing. All interested persons are invited to submit their comments in person or in writing at or before the public hearing.

The draft Recreation Plan may be viewed at [www.lakeodessa.org](http://www.lakeodessa.org) or may be viewed in person at the Page Memorial Building located at 839 Fourth Avenue, Lake Odessa during normal business hours. All

interested persons may attend the public hearing and comment on the proposed Recreation Plan. Written comments will be considered if mailed to: Village of Lake Odessa, Proposed Recreation Plan, 839 Fourth Avenue, Lake Odessa, MI 48849 and received by Wednesday, January 19, 2022 prior to the meeting.
